International Congress **First Republic and Republicanism** is a FCSH-UNL's Institute of Contemporary History initiative, with the support of the National Assembly, to promote the encounter of the research units whose activities and those of their researchers relate to the history of the First Republic and the preparation of a shared program of celebrations for the 100<sup>th</sup> anniversary of the First Republic that epitomize the scientific activity involved.

A century after the **5<sup>th</sup> October Revolution** and more than eight decades after its defeat, First Portuguese Republic is remembered by the politic revolution yet and by the misfortunes of an unstable regime. Nevertheless, Republicanism has been, before it converts into a regime, a modernizing cultural movement too.

People will reflect on all these things at the Congress, in order to assure the most diverse and free discussion about the historical way of the Republicanism and of the First Republic.

International Congress **First Republic and Republicanism** will be a critical meeting of reflexion about the short republican experience, which will confront the most modern research work over the Idea, the Movement and the Regime, among national and international experts, and the contribute of junior researchers from the different institutes of the country. The selection of the papers by a scientific committee will assure diversity and quality of the material presented by all researchers. According the thematic areas, the accomplishments of the seniors speakers invited and the knowledge about the history

of the First Republic and Republicanism nowadays, the organization committee is quite sure to anticipate a relevant contribute, both to the scientific community and the public in general.
